While at 1400 Greene Street, Russell House, I was standing outside of [REDACTED] with counter protesters for an Uncensor America event. At the end of the event, I was notified that an assault had taken place inside of the room. I made contact with Harutiun who stated that after the event ended, some of the counter protesters were in the room. As they left, he told them to have a nice day and then felt a punch to his back. He looked behind him but was unable to observed who had punched him. He then told me that a witness had observed the assault and gave me the individual's information. He stated that he wanted the incident investigated and would pursue prosecution. The interaction was captured on BWC.

After leaving the location I responded to dispatch and contacted the witness via telephone. [REDACTED] stated that [REDACTED] was standing at an angle to Harutiun and observed a [REDACTED] arm swing toward Harutiun's back and heard a thump and the [REDACTED] quickly exited the room. The [REDACTED] was described as a [REDACTED] in height with a [REDACTED] with [REDACTED]. [REDACTED] also had a [REDACTED]. [REDACTED] was standing next to a [REDACTED] with an [REDACTED]. There was no injury reported.
